OBJECTIVE

The plenary sessions brought together representatives of city networks, international alliances, initiatives and organizations actively working to catalyze and accelerate investment into low-to-no carbon and climate-resilient infrastructure in cities and urban areas.

Despite in the last years significant strides have been made, the availability and accessibility of funds to tackle climate change remains limited to drastically scale up local climate action. Yet, the political will is there to act. How can we break through this financial glass ceiling?

The focus of the session was on introducing ongoing activities, funds and initiatives targeting local action and unlocking climate finance. The training session was a more technical and interactive part with a spotlight on accessing finance. Experience of project preparation facilities was shared, as well as the banks perspective on requirements and successful project pitching.

OUTCOMES

Participants left the workshop session with:

- An overview of city networks and initiatives being active in catalyzing finance to scale up local action.
- An improved understanding on projects preparation facilities and initiatives supporting access to climate finance.
- Firsthand information on new Funds serving subnational governments.
- A better understanding on what is an investor-friendly project, what are the requirements of the donors/investors.
- Learning methods for a successful project pitching.
